

















#### Digital Impact Assessment

- Digital practices throughout the Impact Assessment process
  - Focus of activity in EIA, but digital practices have potential in other forms of IA
  - More than just innovative methods of reporting and consultation
- No definitive form or process of Digital Impact Assessment



#### Data Management for Digital IA


- Proactive data management is essential to realise the benefits of Digital IA
- Opportunity to realise benefits of better data management by:
  - Adopting digital or data strategies involve data or geospatial specialists in projects
  - Apply metadata practices
  - Adopt standards
- Increasing availability of open data is an opportunity iema.net






## Other potential uses of blockchain for sustainability
